Affidavit having been made before me by Detective Anthony Rodriguez (ID #04-0562) that he has probable cause to believe and does believe that in the premises described as:

The structure is a single story CBS block building peach in color. structure has an over hanging roof attached to the wall of the structure and runs along the length of the building just above the height of its doors. Below the overhanging roof, the wall of the structure has a brick inlay also peach in color. The premises is the second (2nd) glass, storefront from the southernmost end of the structure. It has glass, double doors with the numbers "3671" clearly marked above the doors in approximately six inch (6") black numerals. There are two (2) lock boxes attached to the glass, double doors alongwith credit card stickers. The word "GINECOLOGIA" is centered on the glass window to the left of the glass doors in approximately six inch (6") pink lettering. The words "T.O.P. I.U.D. SONOGRAM P.A.P. SMER" are also centered on the glass window below the word "GINECOLOGIA". YOU ARE HEREBY COMMANDED to enter and search forthwith "The Premises" above-described, and the curtilage thereof, for "The Property" abovedescribed, serving this Warrant and making the search in the Daytime or Nighttime, as the exigencies may demand or require, or on Sunday, with the proper and necessary assistance, and if "The Property" above-described be found there, to seize it and to arrest all persons in the unlawful possession thereof, leaving a copy of this Warrant and a receipt for the property taken and prepare a written Inventory of the property seized and return this Warrant and bring the property and all persons arrested before a court having



At approximately 7:20 p.m., Ms. Rojas called your Affiant and advised the baby's mother's name was Sycloria Williams, hereinafter referred to as The Complainant, and her home address. At approximately 10:50 hours, your Affiant at the Complainant's home and spoke with her. The Complainant advised on Thursday, 20 July 2006, at approximately 9:30 a.m. she arrived at the clinic for a pre-scheduled abortion. At approximately 2:30 p.m. the Complainant gave birth in the recovery room of the clinic. The Complainant observed the baby moving and gasping for air for approximately five (5) minutes. The staff began screaming that the baby was alive; at which time, Ms. Belkis Gonzalez cut the umbilical cord, threw it into a red bag with black printing. Gonzalez then swept the baby, with her hands, into the same red bag along with the gauze used during the procedure.

After the police had searched the business on 22 July 2006, additional information was received as to the whereabouts of the body and/or the remains of the baby. On July 28, 2006, a source that your Affiant has been speaking with, informed your Affiant that the body of the baby was tossed on the roof top of said building then later retrieved and placed back into the business. Your Affiant believes that the body of the baby and/or the remains of the body are inside of the business. The business is owned by Belkis Gonzalez and Siomara Senises. Siomara Senises has consented to allow your affiant and Hialeah Police Officers to search the business located at 3671 W 16 Avenue, Hialeah, Florida.

Affiant's reasons for the belief that "The Premises" are being used as stated above and that the felony aforesaid has been committed and that "The Property" above-mentioned is being concealed and stored at "The Premises" above-described and the facts establishing the grounds for this affidavit and the probable cause for believing that such facts exist, are as follows:

On 20 July 2006 at approximately 6:57 p.m. an anonymous female called the Hialeah Police Communications Section advising that a baby had been born alive and killed by the staff at the clinic located at 3671 West 16th Avenue, Hialeah, Fl. Marked Hialeah Police Patrol Units responded and found the clinic had closed.

On 21 July 2006 at approximately 10:00 a.m. Ms. Betty Rojas called the Hialeah Police Department and spoke with Homicide Sergeant K. Hart (ID #04-0721). Ms. Rojas advised she spoke with the anonymous female caller who told her the day before a baby had been born, alive in the clinic, and was subsequentely killed by the staff. According to Ms. Rojas, the doctor drowned the baby and placed the body into a plastic bag containing chloride which will dissolve the remains of the baby. Ms. Rojas then verified, to Homicide Sergeant K. Hart, the address to the clinic (3671 West 16th Avenue, Hialeah, Fl).
