INDICTMENT

THE GRAND JURY ALLEGES:

Count One

**18 U.S.C. § 875(c)
(Interstate Communications)**

On or about the 14th day of August, 2018, in the District of Kansas, the defendant,

CHRISTOPHER M. THOMPSON,

knowingly and willfully did transmit in interstate and foreign commerce a communication containing a threat to injure the person of another. That is, defendant made a telephone call threatening: to rape another's daughters; defendant had followed the daughters around town; and, another to be afraid for his or her life.

All in violation of Title 18, United States Code Section 875(c).

Count Two

**18 U.S.C. § 875(c)
(Interstate Communications)**

On or about the 14th day of August, 2018, in the District of Kansas, the defendant,

CHRISTOPHER M. THOMPSON,

knowingly and willfully did transmit in interstate and foreign commerce a communication containing a threat to injure the person of another. That is, defendant made a telephone call, separate from the communication in Count One above, threatening to rape another's daughters and murder another's family.

All in violation of Title 18, United States Code Section 875(c).

Count Three

**18 U.S.C. § 875(c)
(Interstate Communications)**

On or about the 14th day of August, 2018, in the District of Kansas, the defendant,

CHRISTOPHER M. THOMPSON,

knowingly and willfully did transmit in interstate and foreign commerce a communication containing a threat to injure the person of another. That is, defendant made a telephone call, separate from the communication in Counts One and Two above, and left a voicemail threatening another that the devil was going to rape him or her.

All in violation of Title 18, United States Code Section 875(c).

Count Four

**18 U.S.C. § 875(c)
(Interstate Communications)**

On or about the 14th day of August, 2018, in the District of Kansas, the defendant,

CHRISTOPHER M. THOMPSON,

knowingly and willfully did transmit in interstate and foreign commerce a communication containing a threat to injure the person of another. That is, defendant made a telephone call, separate from the communication in Counts One, Two and Three above, and left a voicemail threatening to: kill another; rape another's daughters; and, kill another's family.

All in violation of Title 18, United States Code Section 875(c).
