Jim Larkin,

Thank you for your correspondence on Sept 16, 2019.

Again, I would like to sincerely thank you for cancelling your lease with Planned Parenthood (PP) at your building at [1854 Minnesota Ave](#); this is very positive. The pro-life movement is strongly opposed to Planned Parenthood both nationally and locally. Tragically, PP performs over 300,000 abortions per year in the U.S. And, as I have communicated previously to you, they promote sexual immorality to our youth among the many other morally objectionable activities that they do. Hence, there is very strong opposition to PP which includes conducting peaceful, prayerful events at any PP facility, as well as, conducting such events at organizations that conduct business with PP. For example, earlier this year there was a national campaign to protest waste hauler Stericycle for their involvement with PP in disposing of aborted fetal remains.

We understand that PP is planning on opening a location in KCK. I was at a public meeting last Tuesday that PP held at the KCK public library at 6th and Minnesota. An attendee at that meeting stated that she had heard that PP was opening a location in KCK. The PP presenter responded that they were planning on opening a location within two miles of downtown KCK, but that PP would not discuss this further at this time. PP is also advertising for positions in KCK. Therefore, we will be continuing our *Stop Planned Parenthood in KCK Campaign* which will also include contacting local government officials.

Thank you for considering leasing [1854 Minnesota Ave](#) to Kansas City Pregnancy Clinic (KCPC). We respect your decision to not enter into a lease with KCPC. KCPC will continue looking for another location in the central area of KCK (in same general area as the anticipated PP location) to provide pregnant women with life-affirming services.

Thank you very much for your statement today that, if you sell the building in the future, that you will place a restriction on the deed. Based upon: your statement today; plus cancelling your lease with PP; plus prior statements from you and Sam Garcia including that you "will not be leasing or selling the building to PP or anyone similar now or never"; Planned Parenthood Exposed will, at this time, cease public witness events at [1854 Minnesota Ave](#). Obviously, we do not control individuals who may still conduct activities on the public sidewalks; but we will inform individuals as best we can of your

new statement and previous statements and about Planned Parenthood Exposed's new position of not conducting prayer, peaceful events on these sidewalks.
