GENERAL DENIAL

- 1. Defendant generally denies liability for the claims asserted in Plaintiff's Complaint.
- 2. Plaintiff's Complaint fails to state a claim upon which relief can be granted or a claim upon which relief can be granted against Defendant.

AFFIRMATIVE DEFENSES

- 3. The claims asserted in the Complaint are barred by the doctrine of contributory negligence and/or assumption of risk.
- 4. The claims asserted in the Complaint are barred by the doctrines of collateral estoppel and *res judicata*.

- 8. Defendant is entitled to a reduction of any verdict or judgment entered in accord with §§ 3-2A-05(h), 3-2A-06(f) and 3-2A-09 of the Courts and Judicial Proceedings Article of the Annotated Code of Maryland.
- 9. Defendant expressly denies that she was negligent as alleged in Plaintiff's Complaint or that any alleged act and/or omission attributed to Defendant proximately caused any of the injuries alleged in Plaintiff's Complaint. Rather, those injuries were instead the result of superseding and/or intervening causes.

DEFENDANT ELIZABETH SWALLOW M.D.'S SCHEDULING HEARING STATEMENT

Defendant Elizabeth Swallow, M.D. ("Dr. Swallow"), by her undersigned counsel, submits this Scheduling Hearing Statement in accordance with the Court's Scheduling Order and in advance of the Scheduling Hearing scheduled for February 18, 2022.

A. STATEMENT OF DR. SWALLOW'S DEFENSES

Plaintiff failed to state a claim against Dr. Swallow for medical negligence (Count I) and informed consent (Count II). Dr. Swallow expressly denies any and all liability in this matter. Dr. Swallow asserts and incorporates all of the defenses set forth in her Answer to the Complaint and in the Certificate of Qualified Expert and Report by Dr. Phillip Darney and Co-Defendants.

B. ITEMIZATION OF MATTERS IN MITIGATION OF DAMAGES OR IN <u>OPPOSITION TO THE RELIEF SOUGHT BY DEFENDANT</u>

Dr. Swallow denies that Plaintiff suffered any damages. The cap on non-economic damages is \$830,000.

C. THE MAXIMUM OFFER NOW ACCEPTABLE DR. SWALLOW

Additional discovery is necessary before Dr. Swallow could engage in meaningful settlement negotiations.

D. CONCISE STATEMENT OF THE NUMBER OF WITNESSES AND DESIGNATION OF THE NUMBER AND IDENTITY OF EXPERT WITNESSES

With respect to fact witnesses, it is likely that Ms. Norris, Dr. Swallow and Dr. Carhart will testify. Additional fact witnesses, including Ms. Norris' treating providers from AbortionClinics.Org, Shady Grove Adventist Medical Center and other medical providers, will likely be identified during discovery. Dr. Swallow reserves the right to call any fact witnesses identified by the parties in discovery at trial. With respect to expert witnesses, Dr. Swallow anticipates calling Dr. Philip Darney in addition to other liability experts in the fields of obstetrics and gynecology. Dr. Swallow reserves the right to identify experts in fields other than obstetrics and gynecology to testify in support of her defenses at trial. Dr. Swallow also reserves the right to rely on and/or call Plaintiff's and/or Co-Defendants' experts in support of her defenses at trial.

E. ESTIMATION OF THE AMOUNT OF TIME IT WILL TAKE TO COMPLETE EACH PARTY'S PORTION OF THE TRIAL

Dr. Swallow anticipates that she will need approximately three (3) days to complete her portion of the trial.

PLAINTIFF'S SCHEDULING CONFERENCE STATEMENT

COMES NOW the Plaintiff, Ashley P. Norris, by and through her attorneys, Robert R. Michael, Esquire, Andrew J. Hall, Esquire, and Shadoan, Michael & Wells, LLP, and pursuant to this Court's Order of November 17, 2021, states as follows:

(a) NATURE OF THE CONTROVERSY/PLAINTIFFS' CLAIM

On or about May 11, 2020, Plaintiff Ashley P. Norris sought medical services from Leroy H. Carhart, Jr., M.D.; Elizabeth Swallow, M.D.; AbortionClinics.Org, Inc. a/k/a as ABORTIONCLINICS and/or ACO Incorporated; and ACO Incorporated d/b/a AbortionClinics.Org, Inc., and/or ABORTIONCLINICS, located at 10401 Old Georgetown Road, #104, Bethesda, Maryland 20814, for the purpose of aborting a 25-week gestational age fetus. Plaintiff had contacted a national abortion services company through an 800 telephone number, and was referred to the aforesaid Defendants. After contacting the Defendants, the Plaintiff drove herself from her home in Churchill, Virginia, to Bethesda, Maryland, where she had an initial appointment on May 11, 2020, with the Defendants at the abortion clinic location noted above. At this initial appointment, Plaintiff Ashley Norris was given an ultrasound examination along with oral medications and a vaginal insertion

of a seaweed extract known as "laminaria" designed to cause cervical dilation. Following this procedure, Plaintiff Ashley P. Norris spent the night in a local motel. On May 12, 2020, Plaintiff Ashley P. Norris returned to the abortion clinic in the morning as directed for completion of the procedure. At that time additional oral medications were given to further dilate the uterus. Despite the additional medications, the dilation of the Plaintiff's uterus had not proceeded as expected and she was informed "she had not done much." Around this same time and despite the failure of the Plaintiff's uterus to advance as to dilation, the Plaintiff was placed under anesthesia. Plaintiff Ashley P. Norris awoke during the procedure screaming in pain and was immediately placed back under anesthesia. Plaintiff then began bleeding heavily as a result of a perforation of the uterus and sigmoid colon. These negligent perforations caused pain and excessive bleeding accompanied by a substantial and dangerous drop in blood pressure. Defendant Leroy H. Carhart, Jr., M.D., was called in to assist in the procedure after the excessive bleeding and substantial decrease in blood pressure was noted.

The Montgomery County Fire and Rescue Department were contacted by the Defendants to emergently transport Plaintiff to the Shady Grove Adventist Hospital located at 9901 Medical Center Drive, Rockville, Maryland 20850. Plaintiff Ashley P. Norris arrived in the Emergency Department in critical condition, bleeding, in shock, with dangerously depressed blood pressure, dangerously low hematocrit and hemoglobin levels and respiratory difficulties. Plaintiff Ashley P. Norris was rushed to emergency surgery where the surgeons at Shady Grove Adventist Hospital diagnosed retained fetal parts in the uterus. In addition, the uterus and bowel had been perforated and torn causing excessive blood loss, anemia and respiratory failure. A "large amount" of blood (over 1500 cc's) had to be evacuated from the peritoneal cavity where the uterus and bowel are located. The

sigmoid colon adjacent to the uterus was identified and it was noted to be also perforated and devascularized. There was stool noted throughout the surgical field as a result of the unintended bowel perforation that caused bowel content to leak into the peritoneal cavity which had to be surgically cleaned. As a result of injury to the sigmoid colon, part of it had to be removed and a colostomy bag inserted directing bowel contents outside the body into a pouch created to collect fecal material which colostomy remained in place for several days following the procedure.

The medical records of the ensuing operation state:

"The patient had earlier in the day had a dilatation and evacuation with provider, Dr. Elizabeth Swallow, at an outside institution. Dr. Swallow then called the emergency room to report the patient was on her way, and I did speak to Dr. Swallow verbally over the phone after the procedure, she was concerned for uterine perforation as well as bowel perforation. Per Dr. Swallow, she was also concerned that there was fetal part still in the patient's abdomen. We immediately brought the patient to surgery."

"Immediate inspection of the uterus after it was delivered through the Pfannenstiel incision showed the 5 cm uterine perforation and severe active bleeding from the right lower side of the uterus on the posterior side."

"Upon entering peritoneal cavity, there was a large amount of blood evacuated from peritoneal cavity. Throughout the case, we evacuated ~1100 cc into the suction canister as well as another ~400cc of blood onto the lap sponges and into the surrounding drapes."

The failure by the Defendants Leroy H. Carhart, Jr., M.D., and Elizabeth Swallow, M.D., to properly inform Plaintiff Ashley P. Norris and to properly perform the abortion procedure while acting within their aforesaid duties, agency and/or employment resulted in multiple internal injuries to the Plaintiff Ashley P. Norris including permanent injury to her uterus and bowel.

(b) DAMAGES

Ashley P. Norris claims non-economic damages for her pain, suffering, inconvenience, physical impairment, embarrassment, humiliation, and loss of enjoyment of life, arising from the permanent injuries sustained as a result of the Defendant's negligence. Plaintiff claims economic damages for her treatment at Shady Grove Adventist Hospital (\$38,919.77) as well as her subsequent follow up treatment for injuries to her bowel and uterus.

(c) SETTLEMENT/DEMAND

Plaintiff demands the full damages alleged, including the \$830,000.00 Maryland non-economic damages cap applicable to this claim, as well as her medical expenses including Shady Grove Adventist Hospital (\$38,919.77) and her follow up treatment for injuries to her bowel and uterus, in full and final settlement of this claim.

(d) **WITNESSES**

Preliminarily, Plaintiff anticipates that approximately 4 fact witnesses will be called to provide testimony in this matter. Plaintiff anticipates that she will call 2 experts witnesses in the areas of obstetrics & gynecology and abortion. Plaintiff will provide a Preliminary Identification of Experts pursuant to the Court's Order.

(e) TRIAL TIME ESTIMATE

Plaintiff estimates it will take three (3) days to complete her portion of the trial.
