Dear Dr. Isaacson:

QUAD A has determined that the QUAD A accreditation of **Stanley and Isaacson BCC PC** shall be placed on immediate emergency suspension due to the serious nature of deficiencies cited during the 10/03/2024 survey. **Effective immediately you may not conduct surgery and/or procedures in the facility until your accreditation has been reinstated.**

QUAD A Accreditation is granted only to those facilities that meet and maintain 100% compliance with its accreditation standards. The QUAD A bylaws and accreditation standards provide that QUAD A may place a facility on emergency suspension for failure to satisfy every standard for accreditation. In addition, we will conduct a follow-up survey within 23 calendar days.

QUAD A may place a facility on Emergency Suspension or Emergency Probation status upon receiving information that a state medical, podiatric, or oral and maxillofacial surgery board has taken action, or begun formal proceedings, which may result in it taking action against a license held by a surgeon, podiatrist or oral and maxillofacial surgeon operating at the facility, or the Board of Directors determining that the facility may no longer meet QUAD A standards for accreditation. A facility that has been placed on Emergency Suspension or Emergency Probation status will remain in such status pending an expedited investigation and possible Hearing conducted in accordance with QUAD A procedures available from the QUAD A Central Office.

The emergency suspension will be reported to the Department of Health, Board of Medicine, and appropriate professional societies.

All reports, documents, and records considered in reaching this decision will be made available to your facility upon receipt of a written request and payment of expenses. Within sixty (60) days after receipt of this notice you may (a) submit written information to demonstrate why the emergency suspension should be reversed or (b) request a hearing at which you may present such information as you deem advisable to show that your **Patients First. Always.**



facility's emergency suspension should be rescinded. If you submit written information to the undersigned to challenge the emergency suspension, such information shall be presented to the QUAD A Hearing Committee on Accreditation for consideration. Alternatively, if you request a hearing, the date and time shall be scheduled by the chairman of the committee and a written notice shall be sent to the facility by certified or registered mail not less than thirty (30) days prior to the hearing date (a) specifying the time and place of the hearing and (b) informing the facility that it may, by its representative(s), offer information as it deems proper to refute the findings and proposed decision of QUAD A.

At the conclusion of the hearing, the Hearing Committee on Accreditation shall reach a decision as to whether to terminate the emergency suspension and restore full accreditation, revoke accreditation, or place your facility on a probationary status.

Surgery and/or procedures shall not be performed at a facility that has been placed on emergency suspension. The Board of Directors shall revoke the accreditation of a facility that has been placed on emergency suspension if surgery and/or procedures is performed at the facility at any time following receipt of written notification of emergency suspension by the facility director. If QUAD A learns that surgery and/or procedures, has been performed at the facility because of an unannounced spot check or by other verifiable means, the Board of Directors shall meet via teleconference to vote to revoke the facility's accreditation. If the Board of Directors votes to revoke a facility's accreditation pursuant to this subsection, it shall notify the facility via certified mail. The QUAD A Central Office shall advise the Medical Board in the state in which the facility is located of the decision to revoke the facility's accreditation. The facility may re-apply for Accreditation from QUAD A after a period of one year from the date of revocation.

Absent a submission of written information or a request for a hearing, your facility's accreditation shall be revoked effective sixty (60) days from your receipt of this notice.
